Grangemouth site

The refining and petrochemical site at Grangemouth comprises three businesses:

- 1 INEOS Olefins & Polymers (UK) Europe operates world-scale petrochemical plants. Its finished products of ethylene, propylene, polyethylene, polypropylene, and ethanol are used as building blocks in a multitude of applications that both enable and enhance many aspects of life today, being transformed into housing and construction materials, cabling and insulation, automotive components, fibers and textiles, and food packaging as well as being extensively used in the pharmaceutical and healthcare industries.
- 2 The Petroineos Refinery, a joint venture of INEOS and Petrochina, in Grangemouth is Scotland's only crude oil refinery, processing 150,000 barrels of oil per day. It produces the bulk of fuels in Scotland, with markets in northern England and Northern Ireland.
- The Forties Pipeline System is a 100% INEOS-owned integrated oil and gas liquid transportation and processing system and the largest pipeline system in the UK's North Sea. The Forties Pipeline System is a critical Central North Sea transport infrastructure system, and in 2020, it transported over 30% of the UK's total oil production from the UK Continental Shelf (UKCS) to the mainland.



Technology Plays a Critical Role at INEOS Grangemouth


